



PRIVACY POLICY

Protecting your private information is our priority. This Privacy Policy applies to www.OpenField.AI and OpenField and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to OpenField include www.OpenField.AI, OpenField, OpenField Co and www.openfield.ai. The OpenField website is both a static website used for sales and a functional web app. By using the OpenField website, you consent to the data practices described in this policy.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, OpenField may collect personally identifiable information, such as, but not limited to, your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

If you purchase OpenField's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

OpenField may also collect anonymous demographic information, which is not unique to you, such as, but not limited to, your:

- Age
- Gender
- Race
- Religion
- Political Affiliation
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

OpenField collects and uses your personal information to operate its website(s) and deliver the services you have requested.

OpenField may also use your personally identifiable information to inform you of other products or services available from OpenField and its affiliates.

Sharing Information with Third Parties

OpenField does not sell, rent or lease its customer lists to third parties.

OpenField may share your personal information with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to OpenField, and they are required to maintain the confidentiality of your information.

OpenField may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on OpenField or the site; (b) protect and defend the rights or property of OpenField; and/or (c) act under exigent circumstances to protect the personal safety of users of OpenField, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by OpenField. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the OpenField website.

Security of your Personal Information

OpenField secures your personal information from unauthorized access, use, or disclosure. OpenField uses the following methods for this purpose:

- SSL Protocol

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond our control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and us through this Site cannot be guaranteed.

Right to Deletion

You have the right to control your information stored with us. Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and

- Direct any service providers to delete your personal information from their records.

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Thirteen and Under

Our website is not directed to children. OpenField does not knowingly collect personally identifiable information from children thirteen years of age or under. We do our best to get a parent's or guardian's consent prior to collecting any such personal information from a child. If you are under the age of majority (not an adult), then you must ask your parent or guardian for permission to use this website. After that, we will delete the child's personal information using commercially reasonable measures to ensure that it has been securely deleted.

In order to improve our Services, we may receive a notification when you open an email from OpenField or click on a link therein.

External Data Storage Sites

We may store your data on servers provided by third party hosting vendors with whom we have contracted. These third parties will not use your personal information for any purpose.

We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your account, by placing a prominent notice on our site, and/or by updating any privacy information on this page.
